TARRANT AREA FOOD BANK, FOUNDED IN 1982, IS A PRIMARY SOURCE OF DONATED FOOD FOR APPROXIMATELY 330 HUNGER RELIEF AGENCIES AND FEEDING PROGRAMS IN FORT WORTH, TEXAS AND 13 SURROUNDING COUNTIES. IN FY 2020, TARRANT AREA FOOD BANK PROVIDED ACCESS TO 50 MILLION NUTRITIOUS MEALS THROUGH ITS NETWORK OF PARTNER AGENCIES, MOBILE SOLUTIONS, NUTRITION EDUCATION AND SOCIAL SERVICE PROGRAMS. THESE MEALS WERE PROVIDED IN THE FORM OF BAGS OF GROCERIES FOR CLIENTS TO TAKE HOME, HOT MEALS SERVED ON SITE OR HEALTHY SNACKS SERVED DURING A GROUP ACTIVITY. FOOD DISTRIBUTION INCREASED OVER 50% IN RESPONSE TO THE COVID-19 PANDEMIC AND THE RISE IN FOOD INSECURITY.
