Kelsey Patterson Philanthropist and Community Advocate

Kelsey Patterson, commonly known as "Mrs. P.", is a Fort Worth native who has dedicated her life to helping the community that has given her so much.

Kelsey has volunteered a significant amount of time to help strengthen public education in Fort Worth. Through the Gary Patterson Foundation and now THE BIG GOOD, she has been instrumental in raising substantial funds and awareness for issues facing families

throughout our community, including food and housing insecurity and career readiness.

Kelsey is a founding board member of Saving Hope, a local organization that advocates for animal welfare and encourages safe and kind interactions with animals, including spay and neuter education.

Her most recent philanthropic project, THE BIG GOOD, launched in Fall 2020 and has granted over \$2 million to our community. Bringing together two dynamic leaders in Grammy award-winning recording artist Leon Bridges and legendary football coach Gary Patterson, THE BIG GOOD aims to make the community stronger through unique charitable collaborations. Kelsey managed the concept and formation of THE BIG GOOD and is considered the glue behind the scenes.

Attending elementary school and high school in Fort Worth ISD, she later went on to attend the University of Texas at Austin where she received her bachelor's degree in communications and was recently recognized as an influential alumna in the creative fields.

Kelsey has served various positions since starting her professional career as the Assistant Director of Marketing for the Southwest Athletic Conference (SWC). She worked in Development for Longhorn Athletics at UT Austin before returning to Fort Worth to serve as the Director of Marketing at the Fort Worth Zoo.
